

CO-OP[®] WIN YOUR FILL 2020 – OFFICIAL RULES

The “CO-OP[®] Win Your Fill 2020” game (the “Game”) is offered by Federated Co-operatives Limited (“Game Sponsor”) and is being played at the Game Sponsor’s participating member retail co-operatives’ CO-OP[®] Gas Bars and Convenience Stores (“Participating Retail Co-ops”). The Game is administered by WSP International Limited (“Administrators”). Game Sponsor, Participating Retail Co-ops and Administrators hereinafter will be referred to as the “Game Entities”.

NO PURCHASE NECESSARY TO PLAY.

GENERAL GAME INFORMATION: The Game is being played at approximately one-hundred and seventy (170) Participating Retail Co-ops. You can play and receive entries into the drawings for a chance to win one (1) of two-hundred (200) Free Fuel for a Year prizes, as described in Rule 3 below. You can obtain a free entry without making a purchase also as described in see Rule 3 below. Any questions, concerns or comments regarding the Game can be forwarded to gamemaster@winyourfill.ca or by sending a self-addressed, stamped envelope to “Co-op Win Your Fill, c/o P.O. 1) GAME DATES: The Game begins at 12:01 am ET on July 13, 2020 (the “Game Start Date”) and is scheduled to end on August 23 2020 at 11:59 pm PT (the “scheduled Game End Date”). The period between the Game Start Date and the scheduled Game End Date is known as the “Game Period”. Certain components of the game may end on different dates, as indicated elsewhere in these Official Rules.

2) WHO CAN PLAY: The Game is open to all legal residents of Ontario, Manitoba, Saskatchewan, Alberta, British Columbia and the Northwest Territories who have reached the age of majority in their Province or Territory of residence as of Game Start Date. Employees, operators and directors of Participating Retail Co-ops (“Team Members”), as well as those persons that reside with any Team Member are **NOT** eligible to enter to win prizes in the Game. Employees and members of the Board of Directors of the Game Sponsor and Game Sponsor’s subsidiaries as well as all General Managers, Chief Executive Officers and Board of Directors of any of the Participating Retail Co-ops (“Limited Eligibility Players”) as well as those persons that reside with any Limited Eligibility Player are also **NOT** eligible to enter to win prizes in the Game. Employees of the Administrators or the Game Sponsor’s distributors, sales representatives, advertising and promotion agencies, and agents, participating prize sponsors, or any entity that the Game Sponsor contracts with, specific to this Game, as well as those persons that reside with such employees, are **NOT** eligible to enter to win prizes in the Game.

3) HOW TO ENTER: You can earn electronic entries (“Entries and Bonus Entries”) for the Game in any of the following ways:

A) REGISTER FOR OUR GAME: Visit www.winyourfill.ca at any time during the Game Period to register for the Game. Follow the instructions on-screen to complete the electronic registration form, including but not limited to your name, valid email address and Participating Retail Co-op. Go to <https://www.fcl.crs/contact-us/location> to find a Participating Retail Co-op near you.

B) UPLOAD YOUR RECEIPT: Throughout the Game Period only, registered customers that purchase a minimum of 30 litres of fuel (any fuel type, excluding propane) at any Participating Retail Co-op are invited to upload a picture of their valid cash register receipts for five (5) ballot entries. Receive one (1) additional ballot entry when your purchase includes any advertised qualifying items (“Qualifying Items”) found in any Participating Retail Co-op. Qualifying items are specially marked in-store from the following brands: Pepsi, Old Dutch, Frito Lay, Coca-Cola. Maximum of one (1) bonus ballot entry per receipt upload. Full instructions are provided online. Valid cash register receipts must include proof of purchase made during the Game period and proof of purchase of any Qualifying Items. **All receipts must be uploaded by August 24, 2020 at 11:59 pm PT.**

C) NO PURCHASE ENTRY: Throughout the Game Period, you can request a No Purchase entry. You can obtain five entries without making a purchase by clearly printing your name, complete residential address, phone number, Participating Retail Co-op, and valid e-mail address on a 3” x 5” card. Mail in an envelope with proper postage to “Co-op Win Your Fill, c/o P.O. Box 3009, M.I.P., Markham, ON, L3R 6G4.” There is a limit of five (5) no purchase necessary entry per request per person per day; one request per outer mailing envelope. No mechanically reproduced or computer-generated requests allowed. **All no purchase necessary entry requests must be received by August 23, 2020 at 11:59 pm PT.** Administrator will combine valid no purchase entries with electronic entries prior to subsequent drawings. You will be contacted only in the event that you are a winner.

See Table 2 below for prizes and drawing dates. To enter online you must have at a minimum Internet Explorer 9, Chrome 25.0, Mozilla Firefox 30.00, Opera 16, or Safari 4.0. In the event of a dispute as to who submitted an online ballot entry, the entry will be deemed to be submitted by the “Authorized Email Account Holder” of the email address provided by an Internet access provider, online service provider or other organization (i.e. business, educational institution) that is responsible for assigning email addresses for the domain associated with the submitted email address. The Game Sponsor’s Privacy Policy can be accessed by contacting the FCL privacy officer at privacy@fcl.crs.

All entries become the property of Sponsor and will not be returned. Game Entities are NOT responsible for any lost, late, damaged, incomplete, illegible, misdirected, undeliverable or postage due mail; email, network, electronic, software, equipment, service, processing, accessibility or other errors, failures or issues; unauthorized access, tampering, hacking, theft or destruction; or other technical or human error related to the promotion, execution or administration of the Game.

4) PRIZES: There will be total of two-hundred (200) draws held to award two-hundred (200) prizes of Free Fuel for a Year following the schedule in Table 2 below. Each prize is valued at, and limited to, \$2,000.00 and is awarded in Co-op Gift Cards of varying denominations totaling but not exceeding \$2,000.00. Gift card terms and conditions apply, see card for details.

Draws will be held at the offices of the Administrators and each draw will include all qualifying entries received through the previous day of the drawing. Non-winning entries will automatically roll-over to all subsequent draws.

5) NOTIFICATION AND REDEMPTION: If you have been selected as a potential winner in any of the drawings described above, the Game Sponsor or Administrator will notify you via e-mail, postal mail, registered mail, courier and/or phone. If the selected winner does not respond to the Sponsor’s or Administrator’s notification within five (5) days of the Prize Draw and the Sponsor or Administrator has made two (2) separate contact attempts, the potential winner will be disqualified and a new potential winner will be drawn from among the eligible entries. As a condition of awarding any prize, winner must have signed and returned, within seven (7) days of receipt, the Game Sponsor’s Statement of Compliance, Release, and Indemnity Agreement under which, among other matters, winner confirms his/her compliance and eligibility with these Official Rules, completes, releases and indemnifies Game Entities, and other certain parties. In addition, claimed winners must have correctly answered the mathematical skill-testing question on the Release Form. If a potential winner refuses or fails to timely return the required documents, in accordance with these Official Rules, or is found to have violated the Official Rules of the Game in any way, or is deemed ineligible to receive a prize for any reason, or if any prize or prize notification from Game Sponsor or Administrator is returned as undeliverable, the potential winner will be disqualified and will be deemed to have forfeited the prize in question. If the potential winner is disqualified and forfeits the prize, Game Sponsor may hold a drawing to select an alternate prize winner from among the pool of remaining, eligible entries received. All prizes will be shipped directly to the winner’s address that is provided on their Release Form.

Allow approximately four (4) to eight (8) weeks for shipment of prizes to be mailed to the winner’s address provided on their release form following verification. Prizes may not be transferred or assigned except as provided herein. No prize substitutions are allowed, except as provided herein. Game Sponsor reserves the right, at its sole discretion, to substitute an advertised prize (or portion thereof) with a prize of equal or greater value for reasons that may include, but are not limited to: unavailability; or production delays caused by labour disruptions, adverse weather conditions or other unforeseen events. **No cash or substitution, in whole or in part, is allowed for any prize except by Game Sponsor, except as described herein. Game Sponsor reserves the right to substitute any prize without qualifying it. No compensation or substitute is offered for any portion of the prize not claimed or utilized; any portion of the prize not utilized and its corresponding value will be forfeited. Prizes are not transferable, nor assignable, except as specified herein. Prizes may not be exactly as shown in the Game publicity or promotional materials.**

6) ODDS CHART: Odds for winning any prize depend on the number of qualified entries received prior to each drawing, as described herein.

7) PRIVACY: Game Sponsor will be collecting personal data about you for the Game and for purposes of the game to validate winning submissions. By entering the Game, you consent to the collection of personal data and you grant Game Sponsor permission to send winner notification to you.

No such personal data will be transferred or sold to any third party except in the following circumstances:

- A) When you give us permission to do so;
- B) When in good faith we believe the law requires it;
- C) Under limited circumstances specifically described to you when we collect the information, such as in the rules of games, Game or other promotions;
- D) To our respective agents for data processing purposes, our respective professional advisors and promotional and marketing agencies, provided that such agents, professional advisors and promotional and marketing agencies are restricted from using the information for any purpose other than as described in these Official Rules.
- E) To Game Sponsor’s agents for data processing purposes, or to its professional advisors and promotional and marketing agencies, provided that such agents, professional advisors and promotional and marketing agencies are restricted from using the information for any purpose other than as described in these Official Rules.

Game Sponsor may match aggregated, statistical user information to parameters established by third parties, without releasing any personally identifiable information. Game Sponsor may share aggregate information with trading partners, co-branded locations, participating sponsors and advertisers; however, this aggregated information will not contain personally identifiable information. Any requests for access to the information that entrants have supplied, or to update or rectify such information, must be made in writing by sending a self-addressed envelope with your request to: "Co-op Win Your Fill, c/o P.O. Box 3009, M.I.P., Markham, ON, L3R 6G4".

Federated Co-operatives Limited (FCL) respects your right to privacy and will use your personal information only to conduct the Game and for the purpose as described in the Official Rules. Information collected is used solely to administer the Game and is not sold, rented, or loaned to any third parties. No correspondence will be entered into except with selected entrants (unless you have opted in to receive future offers and communications from CO-OP). FCL will handle the entrant's personal information in accordance with its privacy policies and practices, which can be accessed by contacting the FCL privacy officer at privacy@fcl.crs; and in accordance with applicable laws. By completing and submitting an entry form you consent to the collection use and disclosure of your personal information for the purposes stated herein.

8) PUBLICITY: Acceptance or Submission of a Prize or Prize claim, or submitting an Electronic Entry Registration Form (see Rule 3C above) constitutes permission for the Game Entities to use your name, voice, picture, or other likeness for advertising, marketing, public relations, or other promotional purposes worldwide in commerce and in any media without limitation or further compensation.

9) RESTRICTIONS: The following are prohibited and will result in automatic and immediate disqualification from the Game: (1) Using any method to obtain entries by any means other than those described in these Official Game Rules (see Rule 3 – How To Enter); (2) Using any method that artificially increases odds of winning; (3) Any attempt to forge, duplicate or alter any cash register receipts; (3) using any robotic, automatic, mechanical, programmed or any similar entry duplication method to enter Game or to claim any prize online; (4) non-compliance with these Official Rules; and (5) any other act which the Game Sponsor determines in its sole discretion, jeopardizes the integrity or proper conduct of the Game. Game Sponsor further reserves the right, at its sole discretion, to disqualify, disallow, block entry and prosecute any individual who tampers with or attempts to tamper with the entry process or who enters using any automatic or programmed entry duplication method.

11) ENTRIES and BONUS ENTRIES: Any entry may be rejected and judged void if not obtained through legitimate methods or channels; if any part of any entry including uploaded receipts is illegible, altered, mutilated, counterfeit, defaced, tampered with, forged, or produced in error, incomplete, blank or partially blank, mechanically reproduced or is irregular in any way. All entries submitted become the property of Game Sponsor and will not be returned. Game Entities are not responsible for lost or late entries, or for lost, late or stolen prize submissions. No more than the number of prizes stated in these Official Rules will be awarded.

12) GENERAL TERMS AND CONDITIONS: Participation in the Game constitutes the entrant's ("you" or "your") full and unconditional agreement to and acceptance of these Official Rules including the decisions of Game Entities, which are final with respect to all matters relating to the Game. This Game is void outside the jurisdictions specified in these Rules and where prohibited by law and is subject to all applicable federal, provincial, local, and municipal laws and regulations. The Game Sponsor reserves the right to terminate or withdraw the Game or to amend these Official Rules at any time, without prior notice. As a condition of acceptance of any Prize, the entrant, their heirs, executors, administrators, and assigns, RELEASE AND FOREVER DISCHARGE the Game Entities from and against, any and all Claims (which term includes without limitation all costs and liabilities of any kind (including solicitor fees), actions, claims, causes of action, or proceedings for damages), INCLUDING ANY CLAIMS ARISING FROM ANY ACT OF NEGLIGENCE OF THE GAME ENTITIES, that the entrant now have, or may hereafter have against the Game Entities directly or indirectly resulting or arising from: (i) participation in the Game, or the awarding, acceptance, use, or misuse of the Prize, or traveling to, preparing for, or participating in any Game-related or Prize-related activity; or (ii) the publicity rights granted to the Game Entities as described in the Publicity Release above. It is understood that there may be serious risks of bodily injury, death, or property damage associated with the use or misuse of any Prize, and you voluntarily assume these risks. The entrant may be required to pay any taxes associated with the awarding of any Prize. Any claim or dispute with respect to the Game, the Prize, or this Agreement shall be governed by Saskatchewan law and any proceedings in relation to any such claim or dispute shall be resolved exclusively by Saskatchewan courts. If any portion of this Document is determined to be unenforceable by a court of law, all other parts of this Document shall remain in full force and effect, and that the conditions and covenants herein shall be binding on the entrants heirs and assigns.

GAME SPONSOR RESERVES THE RIGHT TO CANCEL OR MODIFY THE GAME IF FRAUD, TECHNICAL FAILURES INCLUDING WITHOUT LIMITATION ANY PRINTING, NETWORK, SERVER OR HARDWARE FAILURE OR ANY OTHER FACTOR BEYOND THE GAME SPONSOR'S REASONABLE CONTROL IMPAIRS THE

INTEGRITY OF THE GAME AS DETERMINED BY THE GAME SPONSOR IN ITS SOLE DISCRETION. IN THE EVENT SUCH IMPAIRMENT RESULTS IN CANCELATION/MODIFICATION, GAME SPONSOR RESERVES THE RIGHT TO SELECT WINNERS IN RANDOM DRAWINGS FROM AMONG ALL VALID ENTRIES/PRIZE CLAIMS RECEIVED AS OF THE TIME SUCH ACTION WAS TAKEN.
